Purposes of the processing

Your personal data shall be processed for the following purposes:

Types of data processed

The following categories of data included in the special form shall be subject to processing: common personal data, such as personal details and contact details.

Legal basis and provision

The processing of the data is based on the execution of pre-contractual measures adopted at your request (art. 6 letter b) and letter c) Reg. EU 2016/679); the provision of the data is necessary because without it we will not be able to reply to you or offer you the requested service.

Data processing methods

The processing of personal data is carried out by means of the operations indicated in Art. 4 no. 2) GDPR, for the above-mentioned purposes, whether on paper or computer, by means of electronic or otherwise automated tools, in compliance with the regulations in force in particular with regard to confidentiality and security and in accordance with the principles of correctness, lawfulness and transparency and protection of the rights of the individual. Communication and dissemination

Transfer of data
